वरील विषयाबाबत कळविण्यात येते की, शैक्षणिक वर्ष २०२०-२१ पर्यंत प्रथम वर्ष वास्तुशास्त्र पदवी अभ्यासक्रमाच्या प्रवेशासाठी वास्तुकला परिषद (कौन्सिल ऑफ आर्किटेक्चर) यांचे द्वारे घेण्यात येणारी NATA ही प्रवेश परीक्षा व National Testing Agency (NTA) द्वारे घेण्यात येणारी JEE Main(B.Arch) हि प्रवेश परीक्षा ग्राह्म धरण्यात आली आहे.

आता वास्तुकला परिषद (कौन्सिल ऑफ आर्किटेक्चर) यांनी त्यांच्या २०२० च्या विनियमांच्या आधारे स्पर्स्थ्टीकरणाकरिता दिनांक २३.०७.२०२१ रोजीच्या पत्रकाद्वारे (प्रत सोबत जोडण्यात येत आहे ) वास्तुकला पदवी अभ्यासक्रमाच्या प्रवेशासाठी सर्व उमेदवारांना वास्तुकला परिषद (कौन्सिल ऑफ आर्किटेक्चर) यांचे द्वारे घेण्यात येणारी NATA ही प्रवेश परीक्षा उत्तीर्ण होणे अनिवार्य आहे असे सूचित केले आहे. त्यामुळे ज्या उमेदवारांनी इतर कोणत्याही प्राधिकरणाने वास्तुकला पदवी अभ्यासक्रमाच्या प्रवेशासाठी घेण्यात येणारी प्रवेश परीक्षा उत्तिर्ण केली असल्यास अशा सर्व उमेदवारांना वास्तुकला परिषद (कौन्सिल ऑफ आर्किटेक्चर) यांचे द्वारे घेण्यात येणारी NATA ही प्रवेश परीक्षा उत्तीर्ण होणे अनिवार्य आहे असेस्ध्दा सूचित केले आहे.

शैक्षणिक वर्ष २०२१-२२ करिता NATA ही प्रवेश परीक्षा दोन वेळेस घेण्यात आलेली आहे. ज्या उमेदवारांनी NATA प्रवेश परीक्षा अदयापपर्यंत दिली नाही अशा उमेदवारांना संधी देण्यासाठी तिसरी NATA परीक्षा दिनांक ३ सप्टेंबर २०२१ रोजी आयोजित करण्यात येणार असल्याचे पत्रकात नमूद करण्यात आले आहे.याबाबत परिषदेने दिनांक २५.७.२०२१ रोजी संकेतस्थळावर जाहीर नोटीसही प्रसिध्द केली आहे.

उपरोक्तप्रमाणे वास्तुकला परिषद (कौन्सिल ऑफ आर्किटेक्चर) यांच्या दिनांक २३.०७.२०२१ व २४.७.२०२१ रोजीच्या पत्रकातील सूचना आपल्या अधिनस्त असलेल्या सर्व वास्तुशास्त्र पदवी अभ्यासक्रमांच्या संस्थांच्या निदर्शनास आणण्यात याव्यात. तसेच उपरोक्त सूचना वास्तुशास्त्र पदवी अभ्यासक्रमास प्रवेश घेऊ इच्छिणा-या विद्यार्थ्यांच्या निदर्शनास आणाव्यात.

## TO HEADS OF ARCHITECTURAL INSTITUTIONS IMPARTING B.ARCH. COURSE IN THE COUNTRY

Sub: Eligibility Criteria for admission to B.Arch. degree course for the academic session 2021-2022 – Qualifying NATA for admission to Architecture course – reg.

Dear Sir/Madam,

As you are aware, the Council with the approval of the Central Government, had decided to relax the eligibility for admission to 1st year of 5-year B.Arch. Degree Course as prescribed under Regulation 4(1) of the Council of Architecture (Minimum Standards of Architectural Education) Regulations 2020, for the academic session 2021-2022, keeping in view the threat of Pandemic Covid-19. The revised eligibility is stated as under:

"No candidate shall be admitted to architecture course unless she/ he has passed an examination at the end of the 10+2 scheme of examination with Physics, Chemistry & Mathematics subjects or passed 10+3 Diploma Examination with Mathematics as compulsory subject."

(The above relaxation shall be valid for the academic session 2021-2022 only, irrespective of the year in which a candidate has passed 10+2 or 10+3 examination.)

The same was published in the Official Gazette of India on March 23, 2021 and has come into effect from the date of publication in the Gazette. The said notification is available at the website of the Council.

It may be further clarified that as per the Regulations of 2020, all candidates need to qualify an Aptitude Test conducted by the Council (i.e. NATA) for admission to B.Arch. course. Therefore, all candidates who have passed in any other aptitude test in Architecture conducted by other authorities shall also be required to qualify NATA in order to be eligible for admission to the B.Arch. course.

The Council has also further decided to conduct **Third Test of NATA 2021 on September 3, 2021** so that all candidates who have not appeared or qualified NATA in the first Two tests of NATA may be provided last and final opportunity to appear for NATA examination. It may also be mentioned that a candidate shall be allowed to appear for NATA 2021 for a maximum of two times and any candidate who has appeared for both tests of NATA 2021 shall not be eligible to appear for Third Test. The dates and other details regarding conduct of Third Test of NATA shall be soon made available on the NATA portal www.nata.in.



In view of the above, all Universities and Institutions including Govt. Institutions and CFTIs, imparting B.Arch. degree course in the country are requested to ensure that only candidates qualifying NATA 2021 and fulfilling the above eligibility criteria are admitted to 1st year of 5-year B.Arch. degree course during academic session 2021-2022.

The institutions are also requested to give wider publicity to conduct of NATA 2021 among general public and all concerned so that prospective candidates desirous to join Architecture as their profession, may register themselves for the same.

# TO HEADS OF ARCHITECTURAL INSTITUTIONS IMPARTING B.ARCH. COURSE IN THE COUNTRY

Sub: Eligibility Criteria for admission to B.Arch. degree course for the academic session 2021-2022 – Qualifying NATA for admission to Architecture course – reg.

Dear Sir/Madam,

In continuation of our earlier circular dated 23.07.2021 on the above subject, it is hereby clarified that as per NATA 2021 Brochure released by the Council, a candidate shall be allowed to appear for NATA 2021 only for a maximum of two times. Any candidate who has already appeared for both tests of NATA 2021 shall not be eligible to appear for Third Test.

Therefore, candidates who have not appeared in either one or both tests of NATA are eligible to register and appear for Third NATA Test. Further, those candidates who, after registering themselves for NATA, could not appear or remained absent in the either one or both tests of NATA due to any reason, may also register for Third NATA Test.

The important dates and other details regarding conduct of Third Test of NATA shall be made available soon on the NATA portal www.nata.in.

#### **EXAMINATION NOTICE: NATA-2021**

#### **Subject:- Announcement of Third Test of NATA-2021**

The Council of Architecture is pleased to announce that the Third Test of National Aptitude Test in Architecture (NATA) 2021 shall be conducted on September 3, 2021.

As per the Regulations of 2020, all candidates need to qualify an Aptitude Test conducted by the Council (i.e. NATA) for admission to B.Arch. course. Therefore, all candidates who have passed in any other aptitude test in Architecture conducted by other authorities shall also be required to qualify NATA in order to be eligible for admission to the B.Arch. course.

As per NATA 2021 Brochure, a candidate shall be allowed to appear for NATA 2021 only for a maximum of two times. Therefore, candidates who have not appeared in either one or both tests of NATA are eligible to register and appear for Third NATA Test. Further, those candidates who, after registering themselves for NATA, could not appear or remained absent in the either one or both tests of NATA due to any reason, may also register for Third NATA Test.

The NATA portal shall also be opened shortly to facilitate the students to register for Third NATA Test. The NATA-2021 Brochure with details of registration & other important dates for Third test shall be soon uploaded on the websites <a href="https://www.nata.in.gov.in">www.coa.gov.in</a>.

The eligible candidates desirous to take admission into 1st year of 5-year B.Arch. degree course are advised to register themselves for Third Test of NATA-2021.
