

Dear Sir,

I am directed to state that the Executive Committee of the Council of Architecture (CoA) at its 106" meeting held on Sunday, the 15th August 2010, considered the report of the Expert Committee that visited the Pillai's HOC College of Architecture, Tal: Khalapur, Via: Panvel, Raigad, Maharashtra, on 27th May 2010 (copy enclosed), for introduction of 5-year full-time B. Arch. degree course, together with the proposal for introduction of B.Arch. degree course, from academic session 2010-2011.

The Executive Committee has decided to grant approval for introduction of B.Arch. Degree Course at institution with an intake of 40 students from the academic session 2010-2011, for a period of three years i.e. 2010-2011, 2011-2012 and 2012-2013 with the condition that the Institution will submit a letter of affiliation (No Objection Certificate) from the concerned university before making admission in the course. The institution shall also be required to comply with the conditions as stipulated in the report of the expert committee and a compliance report be furnished within 3 months.

The Executive Committee decided to accord approval for the introduction of 5 year full-time B.Arch. degree course as detailed below:-

- 5. The Executive Committee has directed that no student should be admitted in the 1<sup>st</sup> year of 5 ye full-time B.Arch. degree course by the Institution from the academic session 2010-2011 without affiliation a "University" formed under Central/State Legislation.
- 6. The institution to initiate necessary remedial actions based on the enclosed inspection report and se its observations on the same, if any, for further consideration of the Executive Committee.
  - 7. This approval is also subject to compliance of specific conditions attached herewith. The compliance all conditions must be submitted to CoA.
  - 8. The Experts Committee of the Council may visit your premises, if found necessary, to ascertain facts that the said course is imparted as per the Rules/Regulations/Guidelines prescribed by CoA, from time time, under the Architects Act, 1972.
  - 9. Your Institution should follow the "Council of Architecture Minimum Standards of Architecta Education, 2008" which have been prescribed pursuant to Section 21 of the Architects Act, 1972 supplement the Council of Architecture (Minimum Standards of Architectural Education) Regulations, 1983, for impart the above said B.Arch. degree course. This document has already been circulated vide CoA's lead No.CA/5/Academic dated March 19, 2009 to all the stakeholders concerned with architectural education in country and is also available at the website of CoA i.e. www.coa.gov.in
    - 10. Please note that as per the above referred Minimum Standards (i) no candidate, with less than marks in aggregate, shall be admitted to the architecture course unless he/she has passed an examination a end of the new 10+2 scheme of Senior School Certificate Examination or equivalent with Mathematic subjects of examination at the 10+2 level or (ii) 10+3 Diploma (any stream) recognised by Central/: Governments with 50% aggregate marks or (iii) International Baccalaureate Diploma, after 10 year schooling, with not less than 50% marks in aggregate and with Mathematics as compulsory subject examination.
      - 11. Adequate architecture teaching faculty are to be recruited as per the Minimum qualificate experience and structure for teaching posts in a degree level architectural institution as prescribed in Appe BI of the Minimum Standards under reference, You are requested to adopt these Minimum Standards relation and Stages of the Course, Admission to the Architecture Course, Courses and periods of Standards of staff, equipment, accommodation, training and other facilities for technical education Sanctions in your Institution for imparting recognized architectural education under the Architects Act, 19:
      - 12. Please note that the Interview Board or Selection Committee etc. set up for recruitment(s)/promot in respect of architecture teaching faculty positions shall have a representative of the CoA. The said representative will act as a full-fledged Member of the Interview Board or Selection Committee and h scrutinizing the qualification, experience and other relevant details of the applicants for selection of si candidates. Recruitments or Promotions made to architecture teaching faculty positions in your Inst without the involvement of a CoA representative is not acceptable to the CoA. Please also note that the H well as other architecture teaching faculty of your Institution should have valid registration under the Arc Act, 1972 with the CoA.

## specific Conditions:

- The institution should not admit any students in the 1" year of 5 year full-time B.Arch. degre course from the academic session 2010-2011 without affiliation to a "University" formed unde 1. Central/State Legislation.
- The affiliating University shall create an independent Faculty of Architecture and independent Board Studies in Architecture for proper growth and development of course in Architecture and prepar 2. Syllabus, Course Curriculum, Scheme of Examination in accordance with the Minimum Standards Architectural Education as prescribed by CoA. Atleast 1/3 of its members must be from practice.
- In due course, the affiliating University must create Board of Studies in Architecture, Interior Desig Building Construction Technology etc. under the Faculty of Architecture to deal with issues connect 3. with theses disciplines at U.G. and P.G. level, having at least 1/3 of its members from practice.
- The institution must create Course Committees for continuous development of educational programs At least 1/3 of its member must be from practice.
  - The institution must recruit the adequate architecture teaching faculty as per the minim qualifications, experience and structure for teaching posts in a degree level architectural institution prescribed in Appendix-B1 of the "Council of Architecture - Minimum Standards of Architecture Education, 2008" which have been prescribed pursuant to Section 21 of the Architects Act, 1 supplementing the Council of Architecture (Minimum Standards of Architectural Educat Regulations, 1983, for imparting the above said B.Arch. degree course.

The Interview Board small have a representative of CoA.

- Visiting faculty be drawn from practice upto 25% of the teaching load.
- Under the provisions of Section 19(1) of the Architects Act, 1972, CoA experts shall witness the 7. year thesis as well as affiliating University exam, particularly for Architectural Design.
- Stages of the Course: 8.

The stages of the course shall be as per CoA (Minimum Standards of Architectural Education Regulations, 1983. The candidates admitted to the course shall complete the first stage within 5 ye admission to the course.

Admission and Aptitude Test: 9.

> As per the Minimum Standards prescribed by CoA under the Architects Act, 1972, admiss candidates to first year of 5-year B.Arch. degree course shall be subject to their passing an aptitu in architecture.

> All admissions to B. Arch. Course shall be made at 1" year level and it shall be made by 1" worki in the month of September of a calendar year.

- The institution must complete any remaining building within the next three years from now. Ne infrastructure shall be created to make it suitable for Architectur'al Studies.
- The institution must constitute an independent Governing Council for a School of Architecture. Architect members in majority.

- Following infrastructure be created:
  - (a) The institution must have built up space of 3000 sq.mt. within the next three year
  - All spaces must be barrier free (i.e. disabled friendly) The institution must acquire at least 500 titles before the commencement of the course a titles annually and necessary and neces (b) titles annually and necessary subscription be made to get at least 10 professional (c)
  - Workshop facilities for model making and construction related activities be created. A Computer Lab be set up with 40 computers within 3 years along with software rel (d) Visual Art & Architecture.
