The above act shall be brought to the notice of all the staff and students by putting the copy of the sme on the notice board of the institute so as to make aware all the studnets and staff to avoid any act of atrocity as lited in the act, which is punishable for imprisonment for a period of six months or more under provisions of IPC.

The above committee will be for the tenure of one year and will be dissolved by the directions or orders of the head of the institution.
