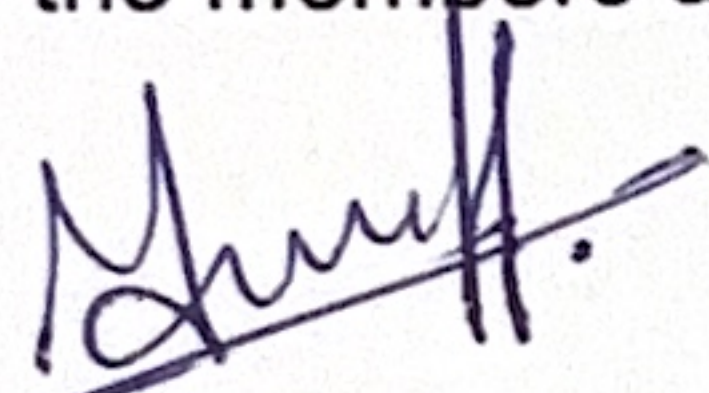

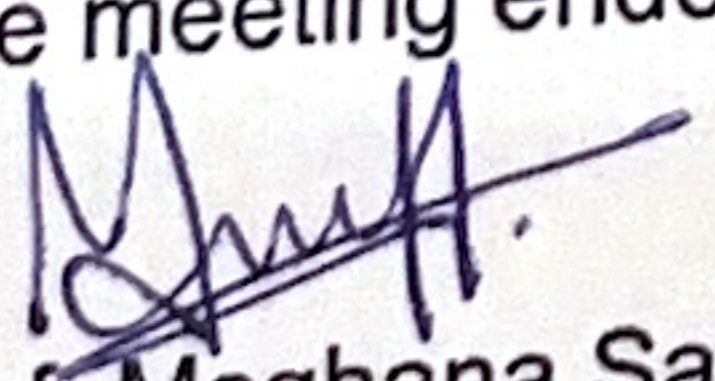
Agenda 4: Discussion on complaints, if any received.

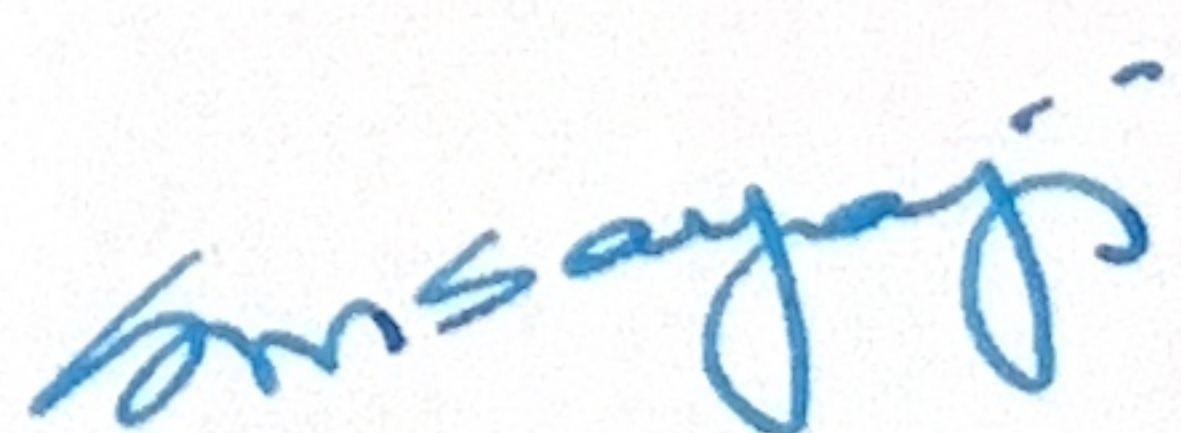
Prof. Meghana Sawant, the Secretary of committee has informed that the committee has not received any complaints from any student or staff member belonging to SC/ST category till date.

The meeting ended with vote of thanks to the chair.

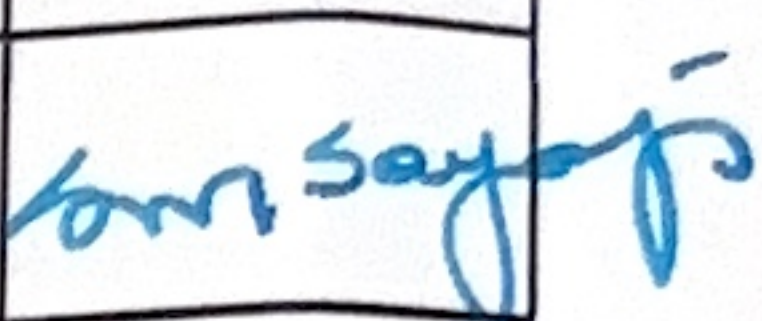
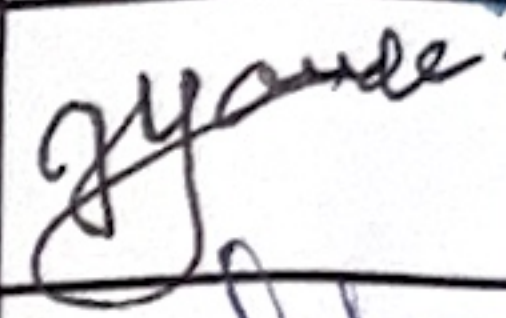
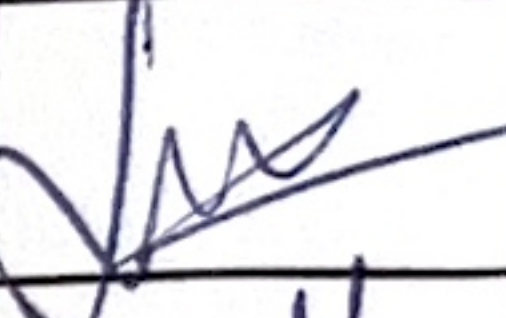
